New/Old Business

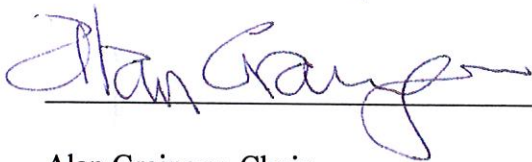
