### 4-STEP DESIGN PROCESS

17.12.030 Four-step design process. 

The city's approach to planning for subdivisions requires a four-step process that gives the highest priority to identification and conservation of existing natural site features.

This process reverses the conventional site planning approach, which typically begins by laying out the streets, lot lines and building footprints. Instead of first identifying the areas to be cleared for development, the design process begins by analyzing on-site resources and the site's relationship to surrounding properties, in order to identify what resources are most worthy of preservation and what areas can best accommodate development.

This design process is required for all residential subdivisions. The process is further defined in BIMC [2.16.125.D](#); it consists of four steps: (A) delineate natural area; (B) locate homesites and community space; (C) define access; and (D) draw lot lines. (Ord. 2019-03 § 5 (Exh. A), 2019)

**NATURAL SITE CONDITIONS:** PRESERVE AND INTEGRATE EXISTING NATURAL SITE PATTERNS AND FEATURES THROUGHOUT THE SITE

**Applicant Response – Natural Site Conditions:**

The site is organized as proposed in order to avoid the wetlands to the west and the steeper slopes to the east, settling the cluster of homes between those on the least sloping areas of the site. The homesites and lots are drawn in such a way as to promote the building of homes that are long along the east/west axis which presents the narrow face of the building to the slope. This reduces the effect on the natural drainage of the site by creating a smaller barrier for water to flow around as it moves downhill.

**WATER CONSERVATION:** PROTECT THE ISLAND'S FINITE GROUNDWATER RESOURCES AND ADAPT TO THE IMPACTS OF A CHANGING CLIMATES

**Applicant Response – Water Conservation:**

The landscape plan calls for replanting of native plants where disturbed and no typical grass lawns are currently planned. While lawns offer some utility, they use a disproportionate amount of water to maintain and offer little in the way of water retention and absorption. The stormwater infrastructure is focused heavily on infiltration and dispersion on the site.

**DIVERSITY IN HOUSE DESIGN:** PROVIDE A RANGE OF HOME SIZES AND DESIGNS TO ACHIEVE DIVERSITY IN VISUAL APPEARANCE AND AFFORDABILITY

**Applicant Response – Diversity in House Design:**

The two homes designs are intended to take advantage of the sloping site, with either walkout basements or garages. The walkout basement could be easily converted to a rental unit, providing another dwelling unit at an more affordable price. The location of the garages is intended to reduce the amount of paving and retaining necessary to access the garage from the cul-de-sac, compared to a home with a side facing garage. The proposed DADUs provide an extra living space that can be used as an office, workshop, guest house or more affordable rental.

The home designs are similar in form due to the naute of the topography, however distinction is made with roof forms and material choices.

**DRB Discussion – Diversity in House Design:**

08/01/2022: The 3-home cluster and 4-home cluster discussion expressed concern that the two designs presented do not meet BIMC 2.14.040.q.1. We are interested in seeing articulation of diversity of house design through material usages, porch entrances, roof without changing the floor plan.

08/15/2022: The unique characteristicts of this heavily wooded site and substanctial slope helps minimize the lack of diversity in the facades. Looking for further design development on facades, such as materiality, texture, modularity to achieve distinctiveness for lower eastern facing homes.

ADU's add an affordable studio component to the islands housing stock.
