Mayor Deets provided an update from the Puget Sound Regional Council (PSRC) General Assembly, Kitsap Transit and Kitsap 911.

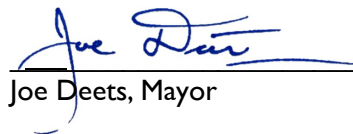
Councilmember Hytopoulos reported on a Kitsap Health District Board meeting.
